Notice To Adult Victims of Family Violence

It is a crime for any person to intentionally cause you any physical harm, even if that person is a member or former member of your household. It is important that you tell the officer if you, your child, or any other household resident has been injured, or if you feel you are going to be in danger after the officer leaves.

Important:

If the officer at the scene believes that family violence has occurred, the officer will arrest the offender at the scene if he/she is present. If the offender is not present when the officer arrives and the officer believes that family violence occurred, the offender may be arrested for family violence at a later date.

You Have The Right To:

Safety for yourself and your children: For information about shelters in your area contact the Harris County Sheriff's Office or the Crime Victim Assistance Unit.

Information and referrals: About the legal system, counseling resources and obtaining court ordered counseling for the offender. Contact the **Harris County Sheriff's Office (HCSO)** or victim services representative.

Court-ordered protection from the Offender: Protective Orders are issued through the District Attorney's office. This order must be issued directly to the offender. It orders him to stay away from you and your family; to stop any communication, directly or through others, that is threatening or harassing; and to stop committing family violence against you.

Any person charged with an offense has a right to bail and is subject to a speedy release. The Harris County Sheriff's Office has no control over this action.

Rights of Victims

As defined in Article 56, Texas Code of Criminal Procedures, a victim of a violent crime is someone who:

- 1. Has suffered bodily injury or death as a result of criminally injurious conduct, or who has been the victim of a crime involving sexual assault, kidnapping, or aggravated robbery;
- Is the close relative (spouse, parent, brother, sister, or adult child) of a deceased victim; or
- Is the guardian of a victim. As a victim of violent crime, you have the following rights:

The right to protection from threats of harm arising from cooperation with prosecution efforts.

The right to have your safety and that of your family taken into consideration.

If requested, the right to be informed in advance about court proceedings, including cancellations or rescheduling.

If requested, the right to information about procedures in the criminal investigation of your case by law enforcement officials, and about general procedures in the criminal justice system, including plea bargaining, restitution, appeals and parole, from the prosecutor's office.

The right to receive information about the Texas Crime Victims' Compensation Fund that provides financial assistance to victims of violent crimes and, if requested, referral to available social service agencies that may provide additional help.

The right to provide information to a probation department conducting a presentence investigation on the impact of the crime.

The right to have a law enforcement agency pay for medical examinations for victims of sexual assault and, on request, the right to counseling regarding AIDS and HIV infection and testing for sexual assault victims.

If requested the right to be notified of parole proceedings by the Victim Services Section of the Pardons and Parole Division, the right to participate in the parole process by submitting a victim impact statement or other information, and the right to be notified of the inmate's release.

The right to be present at all public court proceedings, if the presiding judge permits.

The right to a safe waiting area before and during court proceedings.

The right to prompt return of any property that is no longer required as evidence.

If requested, the right to have the prosecutor notify your employer that the need for your testimony may involve your absence from work. The right to complete a Victim Impact Statement detailing the emotional, physical and financial impact that the crime has had on you and your family, and to have that statement considered by the judge at sentencing and by the parole board prior to taking any parole action.

The right for a victim of a sexual assault to a forensic medical exam within 96 hours of the sexual assault.

The right to consider impact of a continuance request for victim of sexual assault or assault if victim is under 17 years of age or case involves family violence.

Crime Victims' Compensation

Crime Victims' Compensation is a financial assistance program that Please call or write for additional information and/or application: helps eligible victims of crime with certain expenses related to the crime. Money for this program comes from court costs paid by criminals and deposited into the Crime Victims' Compensation Fund.

Crimes covered by Crime Victims' Compensation are those in which the victim suffers substantial threat of physical or emotional harm or death. These may include sexual assault, kidnapping, robbery, assault, homicide and other violent crimes. Vehicular crimes that are covered include FSRA, DWI, manslaughter, criminally negligent homicide, aggravated assault, intoxication manslaughter and intoxication assault.
