PRISON RAPE ELIMINATION ACT (PREA)

Background

PREA was established in 2003 to address the problem of sexual abuse and sexual harassment of persons in the custody of U.S. correctional agencies. Major provisions of PREA include the development of standards for the detection, prevention, reduction, and punishment of prison/jail rapes. This Act applies to all public and private institutions that house adult or juvenile offenders and is also relevant to community-based agencies. The Harris County Sheriff's Office maintains a zero-tolerance policy regarding issues of sexual abuse and harassment involving inmates, and is continuously implementing new policies and training requirements for both staff and inmates, as well as developing standards for the detection, prevention, reduction, and punishment of rape.

PRISON RAPE ELIMINATION ACT (PREA)

DEFINITIONS

- UNFOUNDED- An allegation that was investigated and determined not to have occurred.
- SUBSTANTIATED- An allegation that was investigated and determined to have occurred.
- UNSUBSTANTIATED- An allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.

IN 2025, HARRIS COUNTY JAIL SYSTEM ACQUIRED NEW UPGRADES WHILE UPDATING THEIR VIDEO MONITOR SYSTEMS. THE AGENCY ADDED MORE VIDEO CAMERAS TO AREAS WITH BLIND SPOTS .

IN 2025, HARRIS COUNTY JAIL SYSTEM PROVIDED PREA EMPLOYEE TRAINING TO NEW HIRES.

IN 2025, HARRIS COUNTY JAIL SYSTEM PROVIDED TRAINING TO VOLUNTEERS AND CONTRACTORS.

IN 2025, HARRIS COUNTY JAIL SYSTEM CONTINUED TO CONDUCT ADMINISTRATIVE AND CRIMINAL PREA INVESTIGATIONS.

ANALYSIS

IN 2021, AN LGBTQI NAVIGATOR POSITION WAS CREATED AND FUNDED THROUGH THE FEDERAL PREA GRANT. THE LGBTQI NAVIGATOR IS TO PROVIDE SERVICES TO LGBTQI INCARCERATED AND RECENTLY RELEASED FROM THE HARRIS COUNTY JAIL SYSTEM.

IN 2021, DETENTION OFFICERS NOW HAVE AN OPPORTUNITY TO BECOME PREA INVESTIGATORS. DETENTION OFFICERS WILL INVESTIGATE SEXUAL ABUSE (NON-PENETRATION) AND SEXUAL HARASSMENT
